TACA provided 32 families with scholarships for treatment and therapies through our Family Scholarship Program, Beautiful Son/Autism Hawaii Foundation and Liberty Me Grants. Through our partnership in AutismCares, TACA and four other national non-profit organizations provided financial assistance to 76 families in crisis. Due to a grant by Hope 4 Hanna TACA was able to fund eight week social skills groups (one for girls and one for boys).

For families who have just received the autism diagnosis, TACA aims to speed up the cycle time from the autism diagnosis to effective treatments.
